



ACUERDO CONJUNTO CON MOTIVO DEL ESTABLECIMIENTO

Y LAS BAHAMAS

Los Gobiernos de la República Dominicana y Las Bahamas animados del mejor espíritu de colaboración y convencidos de que la mejor forma de fortalecer la paz y la seguridad internacionales es a través del entendimiento, la cooperación y la amistad entre las naciones, deciden establecer relaciones diplomáticas formales, a nivel de Embajadores Concurrentes a partir del día 4 de septiembre de 1991. Estas relaciones se regirán por la Convención de Viena sobre Relaciones Diplomáticas de 1961.

Ambos Gobiernos manifiestan su confianza en que este acuerdo contribuirá al fortalecimiento de la cooperación mutua en el campo económico, comercial y cultural entre los dos países, los cuales comparten los mismos objetivos y propósitos de promover la paz, la democracia, la justicia y la solidaridad en sus relaciones internacionales, de conformidad con las normas y los principios del Derecho Internacional.

COMMONWEALTH OF THE BAHAMAS AND THE DOMINICAN REPUBLIC


The Governments of the Commonwealth of The Bahamas and the Dominican Republic, convinced that the best way to strengthen peace and international security is through understanding, cooperation and friendly relations between nations, have decided to establish formal diplomatic relations, at the level of Non-Resident Ambassadors, effective 4 September, 1991. These relations will be in accordance with the Vienna Convention of Diplomatic Relations of 1961.

Both Governments express their confidence that this agreement will contribute to the strengthening of mutual cooperation in the economic, commercial and cultural areas between the two countries which share the same objectives and goals of promoting peace, democracy, justice and solidarity in their relations, in accordance with the rules and principles of International Law.
