

## MEMORANDUM OF UNDERSTANDING

1. The delegations of the aeronautical authority of the Republic of Poland and the aeronautical authority of the Dominican Republic met in Aqaba, Jordan on 4<sup>th</sup> December 2019 during the ICAO Air Services Negotiations Event (ICAN2019) to discuss draft text of the Air Services Agreement (ASA). The list of the delegations is attached as Annex 1.
2. The negotiations were held in a cordial and friendly atmosphere and the following understanding has been reached:

### Air Services Agreement

Both delegations review the draft text of the ASA in order to discuss last pending issues.

As the result, both delegations agreed and initialed the text of the ASA, as appears in Annex 2.

Both delegations agreed to remain in contact and to inform each other about the progress of their internal procedure aiming at signature and entry into force of the ASA.

### Capacity and frequencies

Both delegations agreed that the designated airlines of each Contracting Party shall have the right to operate up to 14 flights per week in each direction with third and fourth freedom traffic rights with any type of aircraft for passengers, combination and all cargo flights.

### Entry into force

This Memorandum of Understanding shall come into force from the date of its signature.

Done at Aqaba, Jordan, on 4<sup>th</sup> December 2019.
